## IV. CHAIR REPORT

## V. TREASURER REPORT (Andrea)

2025 budget. Salishan is anticipating fewer people attending, however expenses will go down too. Bench bar is looking the same. Assumptions: same number of members, same dues. We do know Bar support services assessment fee will go up. No recommended contributions this year.

#### VI. Old Business

Still working on coordinating with WCD on the difficulty workers have in finding MCO doctors. Bar has not allowed us to speak to WCD directly. We've been trying for years. Avery Picard in attendance from Bar Legal. Matt Shields also has been working on getting something together. He says they spoke with WCD a week ago on a separate issue, and he and Avery got connected to the "right" people and have a meeting next week. They will push for the creation on an advisory committee. They are cautiously optimistic as WCD seems open to having a conversation.

Issues

- 1. 14 days to find an MCO doc is too few.
- 2. MCO lists are way out of date.

Matt: do we want to have a legislative liaison within the group? No, that subcommittee fell apart so keep sending it to the Chair.

Jovanna: Reminded the group of other WCD issues we have interest in. Is WBF available for interim comp on NCE? Can WCB cover interpretation costs for medical / interpretation costs? Matt thinks we could ask them, but we need a more detailed explanation.

Spencer expressed worry about overwhelming WCD with different issues (WBF access vs. MCO). It was agreed that the issues are so important that it's worth it to present all the WCD when we have the opportunity.

### VII. COMMITTEE REPORTS

#### Access to Justice (Jovanna)

Continuing to pursue WBF access for interim comp on NCE and interpreter access. We discussed that LRS is preventing us from putting a list of foreign languages that attorney's speak on our Bar Section website. Matt shields will look into whether or not this is still the case. Perhaps we can make that change?
